Background

- October 2015 EPA revised Ozone NAAQS from 75 ppb to 70 ppb (8-hour average)
- October 2016 States provided their initial recommendations for designations of counties and cities located within their respective jurisdictions

• EPA Response to States' Initial Designations

- Round 1 (Nov 2017): EPA responded to states' initial recommendations by publishing a preliminary list of counties and cities designated as "attainment/unclassifiable" in each state
- Round 2 (Dec 2017): EPA sent to states a preliminary list of counties and cities designed as "nonattainment". List same as recommended by states
- Public comment period 30 days starting January 5, 2018



Next Steps

• States' Response to EPA Letter

- States had 120 days to respond to EPA's preliminary designations using updated air quality data
- States agreed with EPA's intended designations
- **EPA's Final Designations** Notice signed on April 30, 2018
 - EPA Administrator signed the notice for final designations after receiving and reviewing states' responses to their letter
 - Expected to be published in federal register soon
 - Final designations based on 2014-2016 data



Nonattainment Classification

- Washington, DC-MD-VA region classified as Marginal Nonattainment Area
- Final 2014-16 & Draft 2015-17 Design Values: 0.072 ppm (72 ppb)

Next Steps

Washington, DC-MD-VA 2015 Ozone NAAQS Marginal Nonattainment Area Requirements

- A comprehensive emissions inventory for Base Year
- Transportation conformity demonstration (Required, area has approved (1997 ozone NAAQS) and submitted (2008 ozone NAAQS) MVEBs)
- Periodic emission inventory updates (NEI)
- New source review program
- Major source emission statements
- RACT determination (Required for OTR states irrespective of NA class)

Important Dates

- Attainment date: 3 years from the effective date of designation
- Base Year emission inventory submission: 2 years from the effective date of designation
