The Climate Change Steering Committee has held several discussions regarding the “Cool Capital Challenge,” a grassroots initiative to obtain commitments by April, 2008, to reduce regional greenhouse gas emissions by 1 billion pounds. The CCSC Policy Subgroup met in December and developed a recommended approach for endorsing the “Challenge” for consideration by COG members, as well as adoption by COG as a corporation and building partner. At the request of the CCSC, the Policy Subgroup held discussions regarding federal “Cap and Trade” legislation and potential actions the CCSC could consider regarding advocacy positions. In addition, the Maryland and Virginia legislatures have convened and there are a number of initiatives related to climate change and energy management that could have significant impact on regional efforts to reduce greenhouse gas emissions. Ms. Friedman will summarize the Policy Subgroup discussions on federal legislation and highlight major state climate-related initiatives. (See legislative summary materials.)
