Task Force members will be asked to share the feedback received on a potential regional reciprocity agreement from taxi industry representatives. At the September Task Force meeting, the group decided that it would be helpful and informative for each jurisdiction to approach their respective taxicab industry leaders with a past reciprocity agreement for feedback. Staff recommended using the Northern VA agreement since it has been signed onto and is in effect.

3. Discussion on Enforcement Procedures in the Washington Region (45 minutes)

Staff will present an initial comparison of the enforcement procedures in the region based on the responses to an enforcement questionnaire sent to Task Force members after the September meeting. Task Force members will also discuss enforcement procedures in their respective jurisdiction. Members of the group decided that in developing a regional reciprocity agreement it would be useful to have an understanding of the enforcement processes in each jurisdiction.

4. Selection of 2008 Task Force Chair (10 minutes)

The task force will select a chair for 2008. The Task Force's mission statement says that the chair is to be selected by the task force, serve a one-year term, and rotate between representatives from D.C., MD and VA.
