Mr. Berger will summarize the major changes in Potomac Watershed loads that result from with the new, Phase 6 version of the WS, explain why those changes have occurred, and note the implications for COG's members. Mr. Ibrahim will review initial 2013 Progress sector load charts that compare Phase 5.3.2. to final Phase 6 data for MD/VA/DC state and for MD-Potomac/VA-Potomac/DC. Mr. Ibrahim will also provide a quick overview of COG's Navigation Guide – which can be used by the members to access CBP data for their own jurisdiction.
