Nonpoint & MAR Source Inventories

2022 ozone season day emissions are available for most SCCs along with annual emissions from MARAMA. Using 2022 OSD/annual ratio for each SCC and annual emissions from EPA EMP 2022v1 for 2032 and 2038, projected 2032 and 2038 emissions will be developed.

A few SCCs are missing in MARAMA database that are present in EMP database and vice versa. Those will be reconciled next.

EMP database had most of the airport and yard locomotive (railroad) emissions assigned to point sources. They were reassigned to airport and railroad categories. Line haul in EMP was assigned to nonpoint, was reassigned to railroad.
