## 2. News and Updates

### ***Updates on RESF-1 Related FY05 UASI and HSGP Funded Programs***

- WMATA
  - Public Safety Radio Project with Fire Departments
    - Project will allow jurisdictional Police and Fire Departments to use their home radio system in the WMATA tunnels
    - RFP out on short notice (sole source with original supplier) – done in this manner to meet timeframe requirements with specifications
    - Two objectives for procurement:
      - Bidirectional Antennas (BDAs) which are repeaters/amplifiers in tunnels
      - Alarms for BDAs (109 Alarms will be in by end of the year)
    - There is additional FY06 money to continue the project, and will require more funding in coming years – looking for completion in 2008
  - The Arlington County connection into WMATA public safety radio system project will be going out for procurement shortly
  - DC redundancy into WMATA public safety radio system – Design currently underway and will be completed on time
- DDOT (all funded with State Homeland Security Grant Program (HSGP) Money
  - Walkout Plan
    - Had kick-off meeting a few weeks ago
    - This is a DC project, but there has been/will be collaboration with neighboring jurisdictions
    - Two components:
      - Demand study
      - Plan for how to respond to a walkout emergency – this part requires regional collaboration
  - Evacuation Scenarios
    - Looking at what to do with traffic signals during an evacuation
    - Considering evacuation routes all the way to the Beltway
      - Need to collaborate regionally
      - Goal: How to move the traffic – best process for each jurisdiction
    - QUESTION: Is this initiative tied into the regional Evacuation / Sheltering Planning project?
      - Need to ensure all existing evacuation related initiative are tied into new planning effort
      - EXAMPLE: VDOT is working on a corridor based evacuation plan based on assumptions on current evacuation plans by DC and others
  - Signal Backup Generators
    - Procurement for 200 generators waiting on City Council approval (>\$1M)
  - Connecting DCNET to DDOT and WMATA
    - Should take a month after MOUs are signed to hard wire connection
    - Will take time to create a concept of operations around these connections
  - Freight Security Study
    - First draft of issues analysis back from contractors
    - Working with National Capital Planning Commission (NCPC) to look at realignment of freight line

### ***Update on FY06 RESF-1 UASI Projects***

- All projects listed below are currently moving forward. Each agency owning a project has submitted the necessary initial project plan paperwork. The next step is to submit final project plans in order to receive funding. All projects are on schedule

### ***Update on FY06 DHS Transit/Infrastructure Grant Program***

- Process:
  - The working group has met to distribute the money among the jurisdictions
  - The District of Columbia Office of Homeland Security is submitting the official documentation to secure the funds
    - Projects plans and budgets will be submitted to DC Homeland Security by September 30<sup>th</sup>
    - DC Homeland Security compile plans and submit to DHS by October 16<sup>th</sup>
  - DHS must review and approve plans by end of year
- Example Projects
  - Bus Agencies: Cameras on buses and to monitor facilities
  - WMATA: Additional Funding for Alternate Operations Center
  - MTA: CCTV Coordination
  - VRE: K-9, Infrastructure Cameras, and Emergency Responder Training
- Additional Task: Updating the Strategic Transit Security Plan by the end of October
  - Working Group is revising version developed last year
  - Matt Greenwald of WMATA is coordinating this effort

### ***Regional Transportation Coordination Program (RTCP) Update***

- Steering Committee last met August 4, next meeting August 28
- Partners working through details on master agreement for funding
  - Agreement must be finalized before contractor is given notice to proceed
- Current plan is not to have a dedicated staffed center, but to utilize existing centers and processes
  - Currently, the controls exist at the individual operations centers
  - COMMENT: This idea may have to be adjusted as issues are identified
  - QUESTION: What happened to having an individual(s) who would be responsible for notifying the region if there was a major event?
    - The CONOPS identified ways to achieve this without having a "brick and mortar" stand alone center
    - There is a risk to supporting a stand alone center since this is from earmarked funding
  - COMMENT: Staff should be dedicated to individual control centers – it will be difficult to get agreement from all the parties to have an individual controlling body
    - Must have staff at each agency 24/7 to get the word out if there is an emergency
- RITIS Update
  - University of Maryland making active progress on RITIS which is vital for RTCP to success –
    - EXAMPLE: Recent CONOPS sessions
  - RITIS is not intended to be an emergency response tool – it is for everyday operations
  - WMATA currently provides rail information, but not bus information to RITIS

### **MOITS Update**

- Last met July 11, next meeting September 12
- Continuing work:
  - Compiling data for traffic signals & operations annual report
    - TPB has asked for an annual report based of the traffic signals optimizations study of a few years back
    - Looking beyond just computer optimization to include other operational and maintenance activities
    - Collecting data to get a snapshot of the current state of signals in the region
      - Note: This is not a detailed inventory of equipment
      - Moving forward, this will be a regularly updated view of traffic signals operations
    - Deadline: September 15<sup>th</sup>
  - Update Regional ITS Architecture by end of year
    - Hard to account for emergencies in ITS Architecture planning
    - Architecture: WHAT to exchange, not HOW to do it
  - Expanding safety activities, addressing other SAFETEA-LU requirements

### **National Infrastructure Protection Plan (NIPP) Comments**

- No comments were suggested

### **Operation Fast Forward II After Action Report (AAR)**

- A final draft of the AAR is near completion
  - Holdup: Baseline measurement of travel times along evacuation routes has not yet been collected
- Joe Kammerman will make final version of the AAR available once it is completed

### 3. NCR Evacuation and Sheltering Project Update

- Process Status:
  - RFP for NCR Evacuation and Sheltering Plan was posted on COG website August 10th
  - Proposals are due by August 30th
  - Pre-proposal meeting was conducted August 18th
    - Approximately 15 Contractors attended
    - Questions were general – showed flexibility in planning requirements
  - RESF-1 will be represented on proposal review team
- Plan Components:
  - Evacuation:
    - Routes
    - Signal modification
    - Time frames
    - Evacuation assets/resources
    - Coordination
    - Operational improvements
    - Alerts
  - Sheltering:
    - Locations
    - Capacity
    - Conditions
    - Resources
    - Food / water
    - Special needs
    - Pets
- Project Deliverables
  - Evacuation plans for each jurisdiction that are coordinated across the region
    - Plan will include profiles of evacuation routes, asset inventories, profiles of transfer/pickup locations
  - Profiles of hospitals, assisted living facilities, and prisons
  - Assessments of regional shelters
  - Profiles of what type of support would be needed for 10,000 shelterees per jurisdiction
  - Corrective Action Matrix
  - Hard copies of the plan
  - Dedicated planners in each jurisdiction to assist with project
- RESF-1 Committee Comments on Evacuation and Sheltering Project
  - Want a plan, not a survey
  - Need common procedures and to develop protocols
    - Notification: Who is making the call for an evacuation?
    - Want more information to a wider array of stakeholders
  - Need to see more about the process for implementing the plan
  - Need strategy to anticipate what information is going to be public and what information is going to be private
  - ISSUE: VDOT would need an equivalent of the local planners each jurisdiction is getting
    - VDOT coordinates the traffic operations in each of the Virginia jurisdictions
    - Planning support on the transportation side is needed by VDOT
  - PROTOCOLS! PROTOCOLS! PROTOCOLS!
- RELATED ISSUE: FTA Request for Information from Office of Civil Rights
  - The Federal Transit Administration's Office of Civil Rights may be collecting information regarding special needs populations in emergency transportation planning
    - FTA defines special needs as "**minority and low-income persons, households without vehicles, and persons with limited English proficiency**"
  - Requested Information:
    - Public involvement in plan development
    - Communications of plans to the public
    - Plans to use regional transit systems or coordinated human service transportation (during evacuation and return phases)
    - Coordination across local, state, and federal governments
  - ACTION: Begin to identify local documents that address this request and wait for formal request from FTA

#### 4. NCR Homeland Security Strategic Plan Update

- Purpose of Plan
  - Region-wide strategy for strengthening capabilities
  - Provides approach for planning and decision making regarding funding, measuring performance, and managing implementation
  - NOT AN OPERATIONAL PLAN
- Final version of plan will be presented to the Emergency Preparedness Council (EPC) on September 13
- Below are initiatives that have some relevance to RESF-1 moving forward
  - Grouped into two categories: High and Moderate Relevance to RESF-1
  - Other initiatives have limited impact to the transportation community
  - RESF-1 does not own any initiatives in the plan

## 5. Transportation / Transit Tabletop Exercise Discussion

- ETOP Background
  - ETOP has \$1.5M to provide training and exercises to the region
  - Once a request is made, the ETOP members will approve/disapprove the proposal
  - ETOP has contractors on staff to plan, facilitate an exercise and develop an after action report
  - ETOP funds can be used for staff time
  - Exercises should be regional but not necessarily cross-functional
  - NOTE: Individual agencies/jurisdictions are free to make requests to ETOP to fund desired exercises/training independent of RESF-1
- Transportation/Transit Exercise Requirements
  - Practices vs. Protocols/Procedures
    - There is a need to document regional practices in order to identify a baseline and determine what are the good practices and what are the bad practices and identify what would be a better system in an event, which would eventually lead to the development of formal protocols/procedures
    - Use an exercise to identify issues that need to be resolved
- Possible Ideas for RESF-1 Regional Transportation/Transit Tabletop Exercise
  - Testing communications between transit agencies and transportation centers
  - Hurricane off Delmarva Scenario with influx of evacuees into region
    - Look at requests for resources and where/how to send them
  - Bomb threat
    - Not a complicated scenario for law enforcement, but becomes complicated for transportation (closures, ripple effects, notifications, etc.)
    - Need to understand the status of the transportation system during a big event
  - IDEA: Consider the information already provided in the REETC Annex
- Next Steps:
  - Provide goals and objectives of a tabletop exercise to Natalie Jones best and Robert Young before September 19 RESF-1 Meeting. Examples include:
    - Testing communications between Transportation and Transit Centers
    - Evaluating the ripple effects on the transportation system due to a major event
    - Examine coordination between agencies and jurisdictions
    - Identifying existing “practices” and exploring how to make the regional “protocols”
    - NOTE: *Specifics on scenario are not needed at this time – scenario will be determined that best fits the desired goals and objectives*
  - Reach consensus on what RESF-1 wants to evaluate and what RESF-1 wants to get out of the exercise
  - Develop and submit proposal to ETOP
  - Once ETOP approves proposal, identify Exercise Working Group to work with ETOP contractor to ensure exercise design, facilitation, and AAR meet the requirements of RESF-1
