## 10:55 A.M. 7. TPB GEN3 TRAVEL DEMAND FORECASTING MODEL UPDATE

Mark Moran, TPB Program Director, Travel Forecasting and Emissions Analysis

TPB staff develop and maintain a series of regional travel demand forecasting models (TDFMs), which are used for regional analyses. Staff always maintain at least two versions of the TDFM: A production-use version and a developmental version. The current production-use model is an aggregate, trip-based model, sometimes called a "four-step model," called the Gen2/Ver. 2.4.6 Travel Model. Over the last six years, staff have been developing a new, disaggregate, activity-based model (ABM), called the Gen3 Travel Model. The Gen3 Model is in its third and final phase of development. Mr. Moran will explain how TDFMs are used, describe the motivation for developing an ABM, and give a status report for the Gen3 Travel Model.

## 11:20 A.M. 8. VRE 2050 SYSTEM PLAN

The committee will be briefed on the recently approved Virginia Railway Express (VRE) System Plan 2050, a forward-looking strategy designed to guide the commuter rail system's evolution over the next 25 years. The System Plan 2050 identifies strategic priorities that support VRE's mission to provide safe, reliable, and convenient commuter rail service in Northern Virginia and beyond. The plan lays the foundation for future service expansion, infrastructure investments, and enhanced regional connectivity to meet the region's evolving transportation needs as populations grow and travel behaviors shift.
