OVERVIEW

This Visualize 2050 Future Transportation Investments in Projects and Programs list provides high-level information to familiarize the reader with the planned expenditures in the financial plan based on information provided by the project sponsors.

Visualize 2050 contains hundreds of projects and programs represented by numerous records in the TPB's Project InfoTrak database. The projects cover all modes, ranging from multi-billion-dollar highway and transit projects to local bridge and transit vehicle replacements and bicycle and pedestrian facilities. Many of these projects have gone through decades of planning prior to being included in the plan. Some of these projects are already under construction and will be completed soon. Some smaller projects are captured in project groupings and have not been fully scoped or discretely identified yet the general activities have been captured with an anticipated cost. Ongoing programs may include activities that are routine, involve education or training.

References to project in the legend below include discrete projects, project groupings, and ongoing programs.

Legend

TPB Project Title:	TPB assigned a title for every project enabling a simple understanding of the main activity including the location and limits of the activity, where applicable.
Primary Project Type(s):	Classifies the major purpose or nature of the project using a limited list of options to describe the type.
Completion Year:	The year the project is expected to be completed. For ongoing programs or project groupings, this is typically 2050, the out-year of the plan.
Total Cost:	The expected cost of the project in year-of-expenditure dollars.
Primary Agency:	The primary agency is the agency responsible for the project as well as submitting the information contained in the TPB's project database. <i>Note: The primary agency for all DC projects is the DC Department of Transportation.</i>
Secondary Agency:	This field is only applicable to Virginia where the Virginia Department of Transportation is listed as the primary agency for all highway- and some transit-related projects and the local jurisdiction may have project management oversight for implementing the project.
Bicycle/Pedestrian:	This field indicates whether bicycle and/or pedestrian accommodations are included, not included, or not applicable in the project.
RSAQ:	This acronym means regionally significant for air quality. RSAQ projects involve a capacity change to a major regional road or transit system included in the TPB's travel demand model. Only the RSAQ projects were included in the air quality conformity analysis.
Map:	This field indicates if the agency included a map for this record in the project database.
Record IDs:	This field is a unique identification number assigned to the project. A T record is for projects in the Transportation Improvement Program

	(TIP). A CE record is for projects or project phases beyond the TIP through the outyear of the plan; CE stands for fiscally constrained element. A G record is a grouping used to communicate multiple project segments/phases or projects that have both T and CE records.
