1. REVIEW AND APPROVAL OF RESOLUTION TO AMEND THE FY 2027 UNIFIED PLANNING WORK PROGRAM (UPWP) TO REVISE THE BUDGET TO MATCH AVAILABLE/CONFIRMED FEDERAL AND STATE FUNDING

The FY 2027 UPWP was approved by the TPB and USDOT in March 2026. The District Department of Transportation and the Virginia Department of Rail and Public Transportation (DRPT) provided revised available funding information after the TPB approved the FY 2027 UPWP. TPB staff have revised the total UPWP budget and activities accordingly.

Action: Adopt Resolution SR26-2026 to amend the FY 2027 Unified Planning Work Program.

2. REVIEW AND APPROVAL OF A RESOLUTION TO UPDATE FEDERAL FUNCTIONAL CLASSIFICATIONS IN MARYLAND

The Transportation Planning Board, as a federally designated Metropolitan Planning Organization, works in concert with the state to update urban area boundaries and functional classifications for highway systems. MDOT, on behalf of four counties and two cities in Maryland has proposed updates to their highway system functional classifications.

Action: Adopt Resolution SR27-2026 to update the Highway Systems Federal Functional Classification for MDOT and Maryland jurisdictions.

3. REVIEW AND APPROVAL OF THREE RESOLUTIONS TO AMEND THE FY 2026-2029 TIP THAT MEET OR ARE EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT

Actions:

- Adopt TPB SR28-2026 to amend the TIP to include TIP Action 26-08.2 (MDOT STIP), which adds funding to one project, I-95/I-495 Bridge MD 4 Replacements as requested by MDOT.
- Adopt TPB SR29-2026 to amend the TIP to include TIP Action 26-08.3 (VDOT STIP), which adds two new projects to install CCTV cameras along I-95 in Northern Virginia as requested by VDOT.

- Adopt TPB SR30-2026 to amend the TIP to include TIP Action 26-08.4 (VDRPT STIP), which adds funding to one project, US 1 Bus Priority Transit Project as requested by Fairfax County.

4. SAFE STREETS AND ROADS FOR ALL (SS4A) APPLICATION FOR CONNECTED VEHICLE DEMONSTRATION PROJECT

The U.S. Department of Transportation is currently accepting competitive grant applications for the FY2026 Safe Streets and Roads for All (SS4A) Grant Program to support planning, infrastructure, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users. MPOs and local governments are eligible to apply; state Departments of Transportation are not eligible to apply. Staff are requesting approval for the TPB to submit a grant application in partnership with the District Department of Transportation and private industry partners to conduct a V2X connected vehicle demonstration project to protect vulnerable riders such as cyclists.

Action: Adopt Resolution SR31-2026 to approve submission of a grant application for a connected vehicle demonstration project in the District of Columbia.
