Janie Nham, TPB Transportation Planner

Ms. Nham will brief the committee on findings related to bicycle-involved crashes from the recent update of the Regional Roadway Safety Study. The overview will highlight the number and characteristics of crashes involving bicyclists across the region during the study period (2019-2023). Bicyclist safety is one of six recommended focus areas identified in the study for regional prioritization.

1:25 P.M. 4. HIGHLIGHTS FROM THE 2024 AASHTO BIKE GUIDE UPDATE

Ms. Graham will provide a briefing on the highlights from the most recent version of the American Association of State Highway and Transportation Officials (AASHTO) Guide for Development of Bicycle Facilities, published in 2024. This new fifth edition, update to previous versions, with nine new chapters and significant updates to inform bicyclist operation and safety, facility design, and traffic control elements.

#### 1:50 P.M. 5. LESSONS LEARNED FROM DC'S PROTECTED BIKE LANE INITAITIVES

Stacie Desai, District of Columbia Department of Transportation Senior Transportation Engineer

Ms. Desai will brief the Subcommittee on lessons learned from DC's protected bike lane initiatives. Since 2021, DDOT has completed over 50 projects featuring protected or two-way protected bike lanes, as part of a broader plan launched in 2020 to build 20 miles of new protected bike lanes over three years. The presentation will cover the team's experiences and lessons learned from the design and construction of the protected bike lanes. DDOT is currently conducting public engagement to inform its Strategic Bikeways Plan, which will guide future investments in safe and connected bikeway infrastructure.

This report summarizes regional trends, implementation gaps, and common barriers, and offers recommendations to help agencies advance safety improvements. The second is a white paper examining the effectiveness of Automated Traffic Enforcement (ATE) systems.
