Mr. Claggett will present the recently released Chesapeake Bay Program's 2021-2022 land use/land cover data, specifically for Tree Canopy. He will review updates to the process for obtaining and analyzing the data; present the 2021-22 tree canopy coverage for Maryland, Virginia, and the District of Columbia; and look at how this round compares to the previous 2017-18 imagery.
