SOC Questionnaire and Respondent Survey-Taking Behavior Changes

2025 vs 2022

During the development of the 2025 State of the Commute (SOC) questionnaire, questions were added to or removed from the 2022 questionnaire to maximize data utility while also aiming for the survey to be shorter for respondents. Seven questions were added and 28 were removed, for a net change of 21 fewer questions in 2025 compared to 2022. This has led to a reduction in the median length of time it takes respondents to complete the questionnaire, from 15:30 minutes in 2022 to 12:50 minutes in 2025 (as of May 15, 2025). The mean length of time was reduced from 20:24 in 2022 to 15:57 in 2025 (as of May 15, 2025).

Many questions in the survey are shown to respondents based on their previous responses (e.g., carpoolers are asked how many people are in their carpool, but this question is not asked to non-carpoolers). Because of this, adding or removing questions can lengthen or shorten the survey for either a very small percentage of respondents, all the respondents, or somewhere in between. The tables below show the questions added and removed for the 2025 questionnaire and the percentage of respondents who saw each question (for added questions, these percentages were determined from 2025 data up to and including May 15, 2025, and for removed questions, they were from the total 2022 sample).
