RESOLUTION ON AMENDMENTS TO THE FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) THAT ARE EXEMPT FROM THE AIR QUALITY CONFORMITY REQUIREMENT TO INCLUDE TIP ACTION 23-67.3 WHICH ADDS FUNDING TO THREE ONGOING PROGRAMS AND ADDS A NEW ONGOING PROGRAM FOR PRTC BUS SHELTER PROGRAM AS REQUESTED BY THE VIRGINIA DEPARTMENT OF RAIL AND PUBLIC TRANSPORTATION (VDRPT)

WHEREAS, the National Capital Region Transportation Planning Board (TPB), as the federally designated metropolitan planning organization (MPO) for the Washington region, has the responsibility under the provisions of the Fixing America's Surface Transportation (FAST) Act, reauthorized November 15, 2021 when the Infrastructure Investment and Jobs Act (IIJA) was signed into law, for developing and carrying out a continuing, cooperative and comprehensive transportation planning process for the metropolitan area; and

WHEREAS, the TIP is required by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as a basis and condition for all federal funding assistance to state, local and regional agencies for transportation improvements within the Washington planning area; and

WHEREAS, on June 15, 2022 the TPB adopted the FY 2023-2026 TIP; and

WHEREAS, VDRPT has requested an amendment to the FY 2023-2026 TIP to include TIP Action 23-67.3, which makes the following revisions:

- Adds \$6.1 million in Urbanized Area Formula Funding (§ 5307), Bus and Bus Facilities Program funding (§ 5339), state, and local funding for FY 2026 for the **PRTC – Bus Acquisition/Replacement Program (T4506)**, increasing the total program cost to approximately \$11.7 million;
- Adds a new program for the **PRTC Bus Shelter Program (T5304)** into the TIP with approximately \$212 in Congestion Mitigation and Air Quality Improvement Program (CMAQ) and state funding for FY 2026;
- Adds \$6.4 million in § 5307 and local funding for FY 2026 for the **PRTC – Preventative Maintenance (T5601)** program, increasing the total program cost to approximately \$24.9 million;
- Adds \$2.8 million in CMAQ and state funding to FY 2026 for the **Bus Replacement (OMNIRIDE EXPRESS COMMUTER BUSES) (T6630)** program. An additional \$2.8 million in CMAQ and local for future fiscal years, increasing the total project cost to \$17 million;

WHEREAS, the review and processing of the amendments included in this TIP Action has been conducted in accordance with the procedures detailed in the TPB's Public Participation Plan and the Procedures for Revisions to the Long-Range Transportation Plan and the Transportation Improvement Program; and

WHEREAS, the proposed amendments have been entered into the TPB's Project InfoTrak database under TIP Action 23-67.3 creating the 67th amended version of the FY 2023-2026 TIP, and the draft amendment was posted on the TPB's Steering Committee meeting page in advance of the scheduled approval and can also be found for review online at www.mwcog.org/TIP/FY23-26/Amendments; and

WHEREAS, all four programs are exempt from the air quality conformity requirement, as defined in Environmental Protection Agency's (EPA) Transportation Conformity Regulations as of April 2012; and

WHEREAS, full funding for the programs in this TIP Action was included in the Financial Analysis of the 2022 Update to Visualize 2045 and the FY 2023-2026 TIP, and the TIP remains fiscally constrained, as demonstrated in the attached materials; and

WHEREAS, the attached materials include:

- ATTACHMENT A) Amendment Overview report showing how the amended project records will appear in the TIP following approval, along with a complete listing of all changes made for the most recently approved record version(s),
- ATTACHMENT B) Financial Constraint Summary Table demonstrating that the TIP remains fiscally constrained.
- ATTACHMENT C) Letter from VDRPT dated August 19, 2025, requesting the amendments; and

WHEREAS, this resolution and the amendments to the FY 2023-2026 TIP shall not be considered final until the Transportation Planning Board has had the opportunity to review these materials at its next full meeting.

NOW, THEREFORE, BE IT RESOLVED THAT the Steering Committee of the National Capital Region Transportation Planning Board amends the FY 2023-2026 TIP to include TIP Action 23-67.3, which makes the following revisions:

- Adds \$6.1 million in § 5307, §. 5339, state, and local funding for FY 2026 for the **PRTC – Bus Acquisition / Replacement Program (T4506)**, increasing the total program cost to approximately \$11.7 million;
- Adds a new program for the **PRTC Bus Shelter Program (T5304)** into the TIP with approximately \$212 thousand in CMAQ and state funding for FY 2026;
- Adds \$6.4 million in § 5307 and local funding for FY 2026 for the **PRTC – Preventative Maintenance (T5601)** program, increasing the total program cost to approximately \$24.9 million;
- Adds \$2.8 million in CMAQ and state funding to FY 2026 for the **Bus Replacement (OMNIRIDE EXPRESS COMMUTER BUSES) (T6630)** program. An additional \$2.8 million in CMAQ and local for future fiscal years, increasing the total project cost to \$17 million.

The Virginia Department of Rail and Public Transportation (DRPT) requests an amendment to the FY 2023-2026 Transportation Improvement Program (TIP) on behalf of PRTC. This amendment will reflect funding changes for **3 projects** necessary for PRTC to apply for federal funding, and will add a new project: **PRTC Bus Shelter Program**. The amendments are as follows:

PRTC Preventive Maintenance (TIP ID: T5601|STIP ID: PRTC0004)

This amendment adds additional funding to the PRTC Preventive Maintenance project, which will provide for maintaining buses owned by PRTC and in PRTC's facility. PRTC's Bus Contractor, Keolis, maintains the buses and other fleet vehicles, as well as the maintenance bays and the bus storage yard which includes a bus wash and fueling bays.


