Why is the TPB concerned with Access for All?

Federal Requirements

- Civil Rights Act of 1964 Title VI
- Rehabilitation Act of 1973
- Americans with Disabilities Act of 1990
- Public Participation in Transportation Planning 23 CFR 450.316

The Access for All (AFA) Advisory Committee

- Established in **2000*** to bring the transportation concerns of low-income, traditionally underserved communities, Limited English Proficiency (LEP), older adults, and persons with disabilities into the regional transportation planning process.
- Reorganized in 2016 by combining with the Human Services Transportation Coordination Task Force.
- Provides feedback to the Transportation Planning Board on issues important to these communities.
- Comprised of members and ex-officio members.
 - Members represent a nonprofit group or serve on an advisory committee related to the work of the committee.
 - Ex-Officio members work for state or local agency, transit provider, or are a private provider of transportation services.

This recruitment effort is for members and ex-officio members.

.....advises the TPB on transportation issues, programs, policies, and services important to traditionally underserved communities, including low-income communities, traditionally underserved ethnic communities, people with limited English proficiency, people with disabilities, and older adults. The committee identifies issues of concern to traditionally underserved populations to determine whether and how these issues might be addressed within the TPB process.

Schedule:

Quarterly, with additional times for topic-specific fora. There is always a virtual option.



AFA Objectives

- Facilitate regional discussion about issues important to the community
- Provide feedback to the TPB on the National Capital Region Transportation Plan (Visualize), other long-range planning efforts, studies, and transportation issues
Specifically, provide guidance on updates to the Coordinated Public Transit Human Services Transportation Plan which must be revised every 4 years and disparate impacts information in the constrained long-range plan (Title VI requirement)
- Provide input on the priorities for the TPB's solicitation for Enhanced Mobility grant applications
- Serve as a forum for coordination among community groups and human service agencies at the regional level



2025-2026 AFA Work Plan Priorities

In addition to the National Capital Region Transportation Plan and other long-range planning efforts, over the next two years the AFA will:

- Refresh the AFA structure and organization with an eye toward making the committee more relevant
- Provide input on the priorities for the TPB's solicitation for Enhanced Mobility grant applications
- Participate in regional forums and workshops to represent traditionally underserved communities, for example, the Regional Curbside Management Forum
