The Nominating Committee will present its proposed slate of TPB officers for 2026, which the board will be asked to approve.
Action: Approve the calendar year 2026 slate of TPB officers.

12:55 P.M. 8. **APPROVAL OF THE VISUALIZE 2050 NATIONAL CAPITAL REGION TRANSPORTATION PLAN, THE FY 2026-2029 TRANSPORTATION IMPROVEMENT PROGRAM (TIP), THE AIR QUALITY CONFORMITY ANALYSIS, AND THE MPO SELF CERTIFICATION STATEMENT**

Staff will review the outcomes of the public comment period, the updated materials, and recommend the following for Board Approval: draft Visualize 2050 and FY 2026-2029 TIP, draft Air Quality Conformity Analysis and the Self-Certification Statement.
Action 1: Adopt Resolution R3-2026 finding that Visualize 2050 and the FY 2026-2029 TIP conform with the requirements of the Clean Air Act Amendments of 1990.
Action 2: Adopt Resolution R4-2026 approving the Visualize 2050 and the FY 2026-2029 TIP.
The Joint Planning Regulations issued by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) require that “concurrent with the submittal of the entire proposed TIP...the state and MPO shall certify at least every four years that the metropolitan transportation planning process is addressing the major issues in the metropolitan planning area and is being carried out in accordance with all applicable requirements...” The board will be briefed on the Statement of Certification and asked to approve it.
Action 3: Adopt Resolution R5-2026 endorsing the appended Statement of Certification.

The board will be briefed on the projects recommended for funding under the Federal Transit Administration’s Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities Program for the Washington DC-VA-MD Urbanized Area. The board was briefed on the solicitation and selection process at its July and November meetings and the TPB officers have concurred with the recommended projects for funding. The board will be asked to approve the recommended projects for funding.
Action: Adopt Resolution R6-2026 to approve funding recommendations for Enhanced Mobility.
