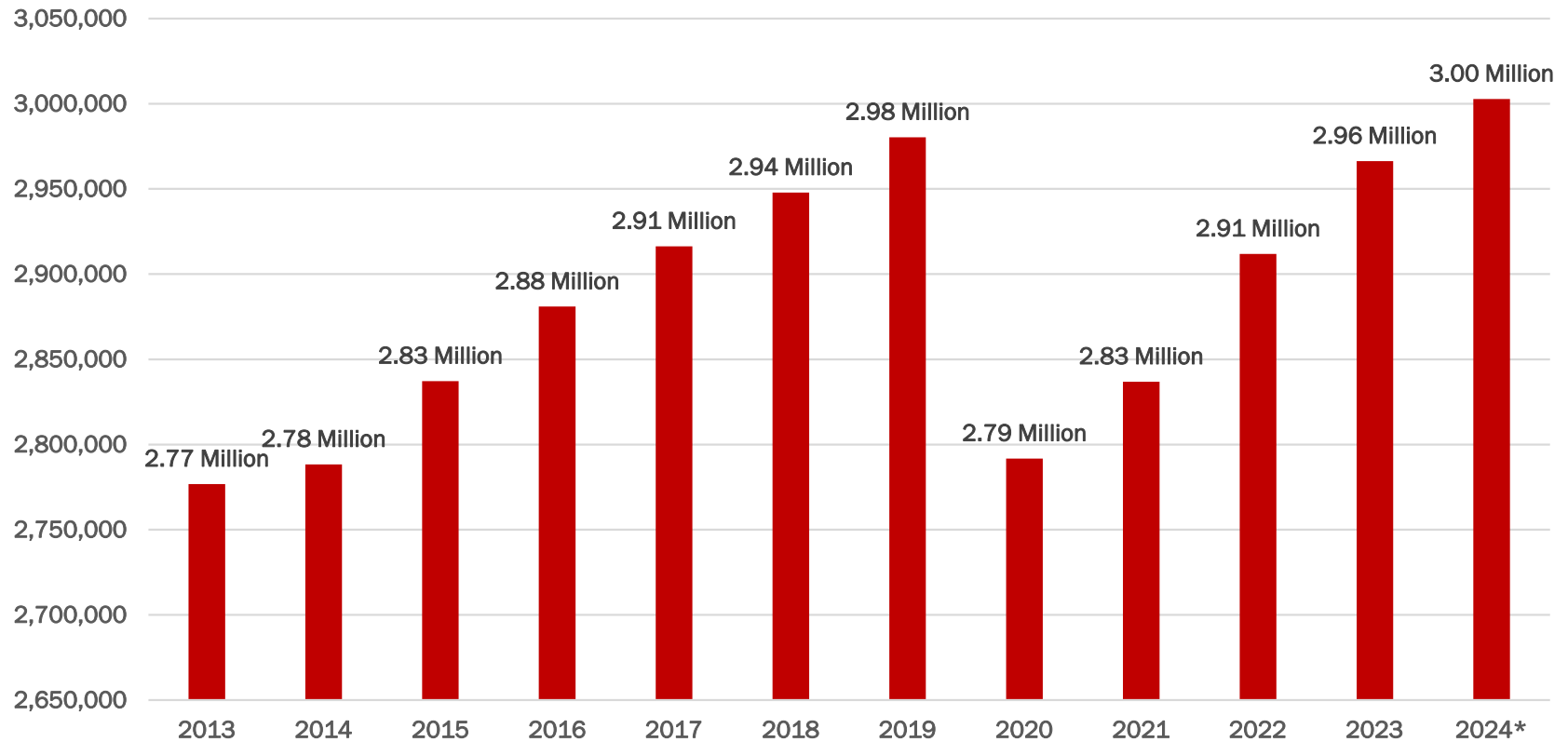

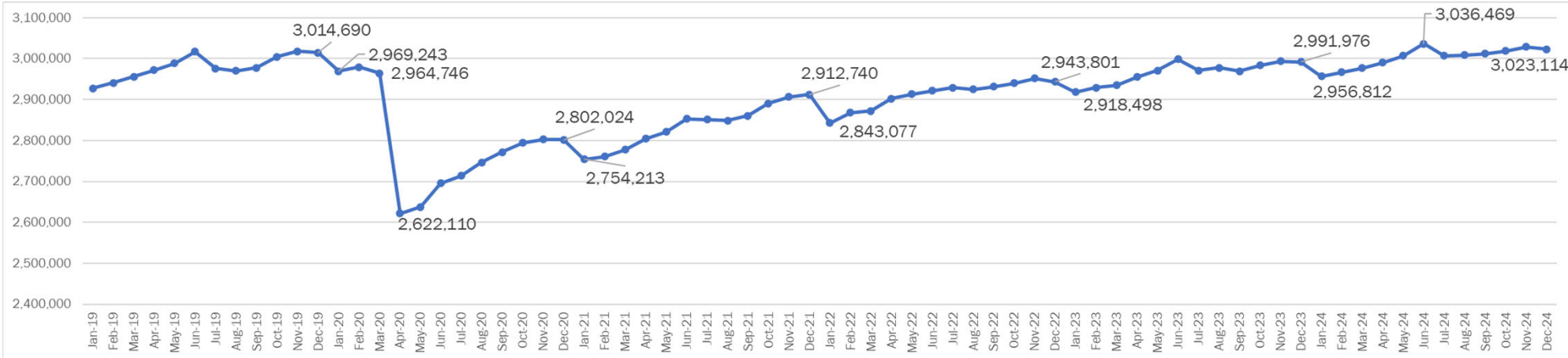

QCEW Annual Data for COG Region, 2013 - 2024



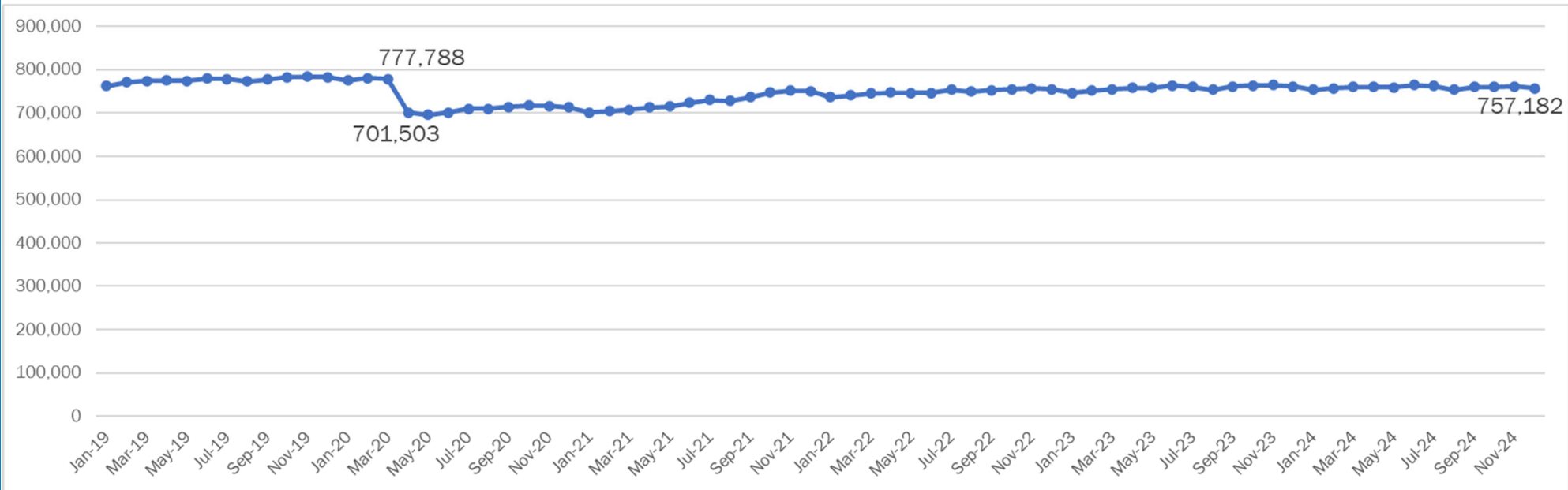

QCEW Monthly Data for the COG Region



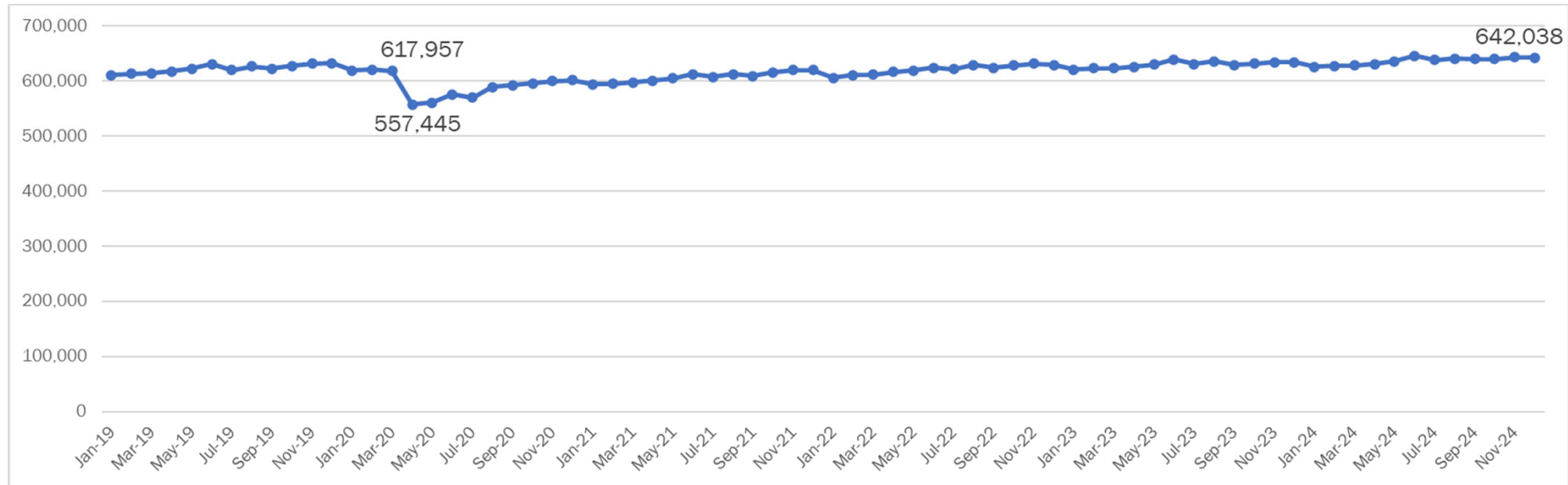

QCEW Monthly Data for the District of Columbia



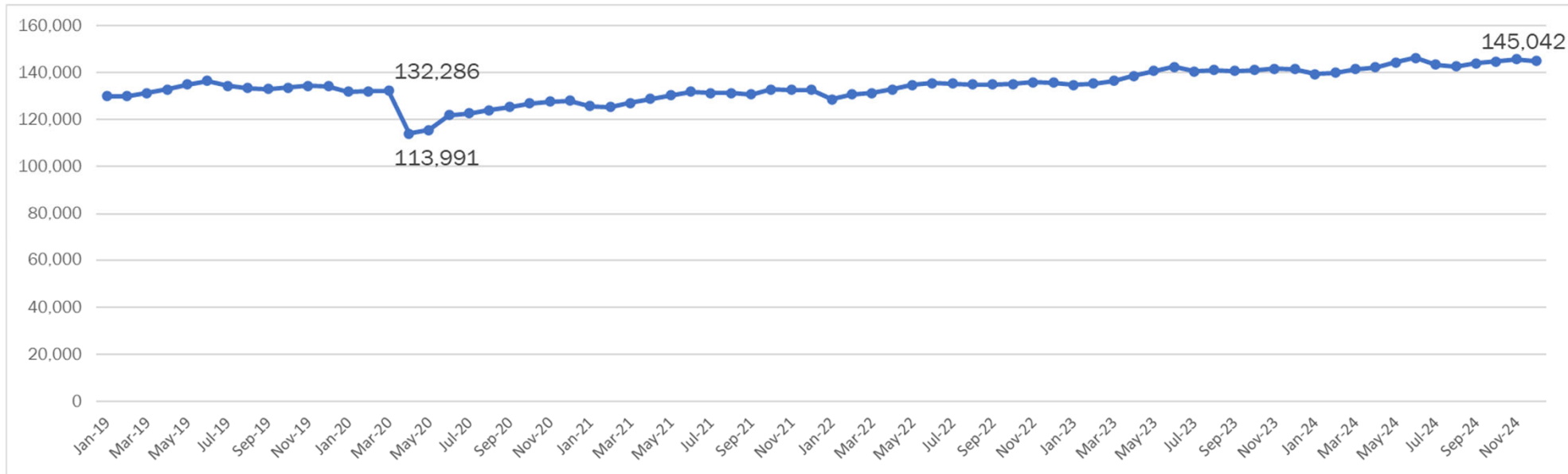

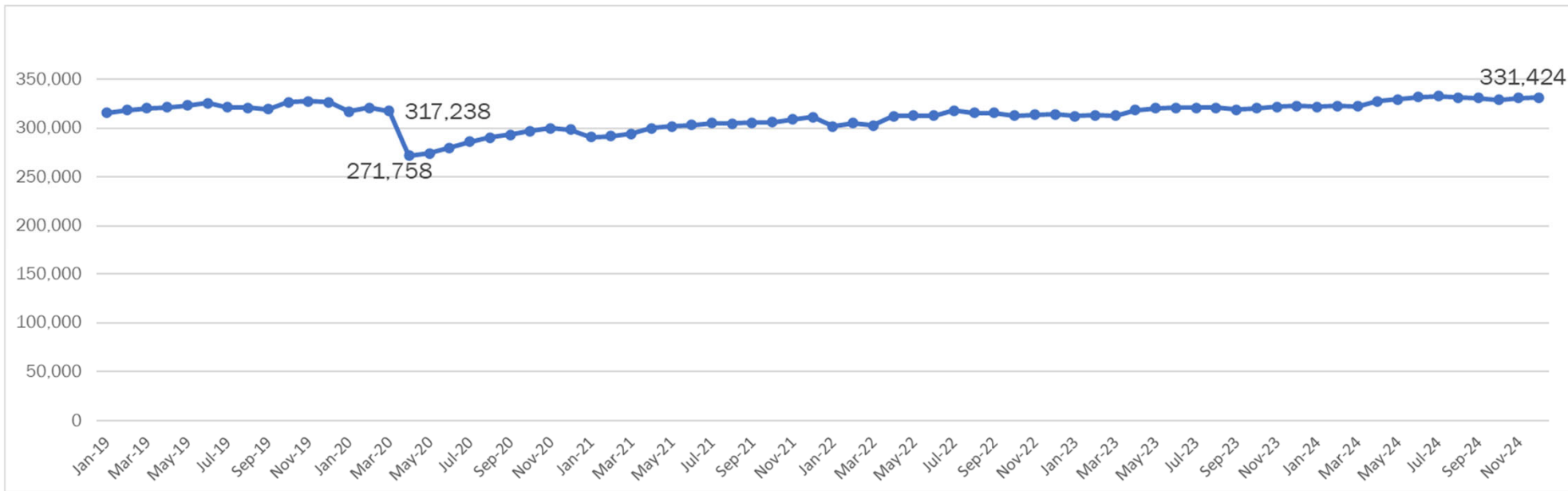

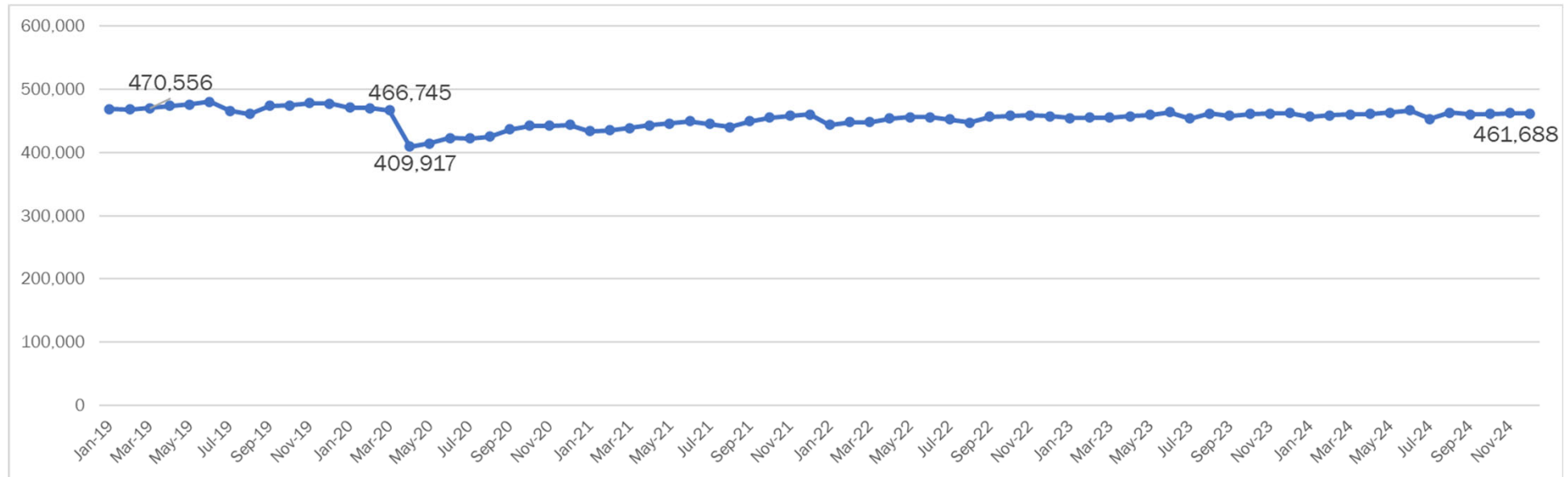
