COG, with consultant support from ICF, Straughan Environmental, and CHPlanning, completed the Regional Blue-Green Infrastructure Community Engagement and Planning

Project in June 2025. The purpose was to increase resilience in three subwatersheds that span the District of Columbia and Prince George's County—Watts Branch and Arundel Canal (part of the Northwest Branch) of the Anacostia River and Oxon Run part of the Potomac River watershed. The project focused on engaging traditionally disadvantaged communities in flood prone areas to identify BGI projects that can assist in the mitigation of flood impacts. Mr. Arrowsmith will provide an overview of the project, highlighting the flood modeling and BGI concept planning process.
