- COG staff track various bills during the legislative session that fall within COG's legislative priorities
- A series of ad hoc calls are held to determine specific bills to send comment letters on
- The committee primarily runs from January – April

Virginia Legislation

1. Emissions

1. **HB 154:** Would require data centers to publicly report when using emergency generation
2. **HB 507:** Would limit amount of emitting backup generators and would require energy storage as backup power.
3. **SB 69:** Would repeal requirements requiring regulations to reduce carbon dioxide emissions from electricity generating sources
4. **SB 5:** Would establish a task force to determine and address barriers to access to energy efficiency programs

2. Infrastructure and Development

1. **HB 324:** Would create an Electric Vehicle Rural Infrastructure Program and Fund to offset installation costs in certain localities on or within one mile of public land.
2. **HB 562:** Would authorize electric cooperatives to establish virtual power plant programs



Maryland Legislation

1. Renewable Energy

1. **HB 345:** Would authorize the purchase, installation and use of portable solar energy generating systems. Balcony solar.

2. Greenhouse Gas Initiative

1. **HB 66:** Would withdraw Maryland from the Regional Greenhouse Gas Initiative (RGGI).

3. Emissions

1. **HB 167:** Would prohibit the State from purchasing gasoline powered leaf blowers and prohibit the State or any contractor or subcontractor employed by the state from using gasoline powered leaf blowers.

4. Financing

1. **SB 23:** Would establish the Green and Renewable Energy Efficiency for Nonprofits Loan Program to provide financial assistance in the form of no-interest loans to nonprofit organizations for the planning, purchase, and installation of qualifying energy systems and for actions that improve energy efficiency.
