Approval of the Visualize 2050 National Capital Region Transportation Plan, the FY 2026-2029 Transportation Improvement Program (TIP), the Air Quality Conformity Analysis, and the MPO Self Certification Statement

**Action 1:** Adopt Resolution R3-2026 finding that Visualize 2050 and the FY 2026-2029 TIP conform with the requirements of the Clean Air Act Amendments of 199

**Action 2:** Adopt Resolution R4-2026 approving the Visualize 2050 and the FY 2026-2029 TIP.

**Action 3:** Adopt Resolution R5-2026 endorsing the appended Statement of Certification.

**Background:** Staff will review the outcomes of the public comment period, the updated materials, and recommend the following for Board Approval: draft Visualize 2050 and FY 2026-2029 TIP, draft Air Quality Conformity Analysis and the Self-Certification Statement.

The Joint Planning Regulations issued by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) require that “concurrent with the submittal of the entire proposed TIP...the state and MPO shall certify at least every four years that the metropolitan transportation planning process is addressing the major issues in the metropolitan planning area and is being carried out in accordance with all applicable requirements...” The board will be briefed on the Statement of Certification and asked to approve it.

## OVERVIEW

The final public comment and inter-agency review period for the draft Visualize 2050 National Capital Region Transportation Plan, FY 2026–2029 Transportation Improvement Program (TIP), and the accompanying Air Quality Conformity Analysis Report was conducted from October 23 to November 21. In addition to providing an opportunity for the public to offer feedback on these documents, the comment and review period allowed regional stakeholders and implementing agencies to provide technical corrections and updates to financial programming to reflect continually changing needs and to ensure that critical funds keep flowing to projects that are currently underway. This memo provides an overview of these changes.

## CHANGES MADE TO VISUALIZE 2050 AND THE EXECUTIVE SUMMARY

Since the final comment period began, some changes to the draft Visualize 2050 plan and executive summary have been made. Upon a final internal review of the plan, TPB staff made minor grammatical corrections, revisions to technical information, corrections to footnote formats, corrections and updates to tables and graphs, adjustments to general formatting, a replacement of a photo, and added a small amount of language.

## CHANGES MADE TO THE FY 2026-2029 TIP

TPB staff worked closely with staff from the eight implementing agencies listed on the following pages to update more than 70 project and program records included in Appendix A of the draft TIP. TPB staff reviewed the updates and have confirmed that all regionally significant projects were included in the Air Quality Conformity Analysis of Visualize 2050 and the FY 2026–2029 TIP and that any other updates made were exempt from the conformity requirement.

Records were updated for projects and programs in the District of Columbia, suburban Maryland, and northern Virginia, as well for regional agencies like WMATA and the TPB. This required a recalculation for all the analytic tables in chapters 2 through 4 of the TIP document as well as regenerating the project description reports for Appendix A. What follows is a summary of the updates that have been made to the draft TIP prior to its scheduled approval by the TPB on December 17.

## **SUMMARY OF ALL CHANGES MADE TO THE DRAFT TIP DOCUMENT**

- Total count of project and program records increased from 355 to 364.
- The four-year program total funding level increased from \$17.73 to \$17.91 billion.
- A new section has been added for each agency to reflect project records in financial close-out.
- Eleven project records were converted from plan (CE) to TIP (T) project records.
- Two project records were removed from the TIP.

## **SUMMARY OF ALL CHANGES MADE TO RECORD LISTINGS IN APPENDIX A OF THE DRAFT TIP DOCUMENT**

### **District Department of Transportation (DDOT)**

- DDOT moved three project records to financial closeout:
