- Adopt TPB SR25-2025 to amend the TIP to include TIP Action 23-53.2 which consolidates two State Highway Administration (SHA) bridge replacement projects into one and adds funding to Maryland Transit Administration's (MTA) Prince George's County Bus and Bus Facilities Competitive Low-No Grant, as requested by the Maryland Department of Transportation (MDOT)
- Adopt TPB SR26-2025 to amend the TIP to include TIP Action 23-53.2 which adds funding for the Golden Mile Multimodal Connection Planning project, as requested by the City of Frederick
- Adopt TPB SR27-2025 to amend the TIP to include TIP Action 23-53.2 which adds funding for the Veirs Mill Bus Rapid Transit project, as requested by Montgomery County
- Adopt TPB SR28-2025 to amend the TIP to include TIP Action 23-53.3 which adds a new project titled DASH Technology Phase II, as requested by the City of Alexandria
