1. WELCOME & INTRODUCTIONS

Chair Boddye welcomed members and asked them to introduce themselves.

2. MEETING SUMMARY APPROVAL

The CBPC approved the draft summary for the March 2025 CBPC meeting.

3. SALT INFLUX FROM LAND AND SEA

Dr. Sujay Kaushal, UMD

Dr. Kaushal presented on new research done in collaboration with other institutions which reveals that multiple overlapping threats are making fresh water saltier. This included a broad view of chloride related threats, sources of influx, effects of climate variability, and interactions between chemicals in freshwater. Dr. Kaushal mentioned factors such as the 'squeeze' of both land and sea delivered salt, 'flashiness' of precipitation and effects of drought, and tidal waterbody issues. Discussion covered potential future management actions and the importance of monitoring.

4. PRINCE WILLIAM COUNTY ENERGY AND SUSTAINABILITY MASTER PLAN

Giulia Manno, Prince William County Sustainability Officer

Ms. Manno presented on Prince William County's Community Energy and Sustainability Master Plan (CESMP), with focus on the County's implementation of climate adaptation and resiliency actions. Ms. Manno covered the genesis of the CESMP, including the involvement of various stakeholder groups, the integration of the plan into county processes, and actions taken to implement it since approval. This included topics such as resiliency, green zoning, building efficiency, and energy. Discussion covered the complexities of data centers including their impact on energy use and local government ability to regulate them in VA.

5. USGS CHESAPEAKE BAY STUDIES: AN OVERVIEW OF SCIENCE USED TO INFORM MANAGEMENT ACTIVITIES

Jimmy Webber, USGS

Mr. Webber provided an overview of USGS activities that inform protection and restoration of the Chesapeake Bay and its watershed. The presentation highlighted recent science accomplishments from fiscal year 2025. These included topics in clean water, habitat, land use, and community engagement. Specifically, USGS work included monitoring trends in nutrients and pollutants, studying the health of streams, wetlands, and living resources, mapping land use, and creating decision support tools for communities. Discussion covered emerging contaminants, the importance of monitoring, and the ability to balance development and protection.
