


COMMUNITY-WIDE GREENHOUSE GAS INVENTORY SUMMARY

Frederick County, Maryland

EMISSIONS SUMMARY

Frederick County community-wide net greenhouse gas (GHG) emissions decreased by 47% between 2005 and 2023, despite a 29% growth in population. Forests and trees result in the net sequestration of more than 565,000 metric tons of CO₂ equivalent (MTCO₂e) annually, or 16% of total emissions.



GHG CONTRIBUTION ANALYSIS

The Frederick County GHG Contribution Analysis results show what has driven increases and decreases in emissions between inventory years 2005 and 2023. The graph shows the main drivers increasing emissions (red bars) are growth in population, commercial space, and hydrofluorocarbons (HFCs). Driving down emissions (blue bars) are mainly decreased commercial electricity energy intensity, a cleaner grid, and cleaner cars.

INVENTORY BACKGROUND AND METHODOLOGY

The Metropolitan Washington Council of Governments (COG) and local governments across metropolitan Washington collaboratively established the regional GHG emission reduction goals of 10% below business-as-usual projections by 2012 (back down to 2005 levels); 20% below 2005 levels by 2020; 50% by 2030; and 80% by 2050. Frederick County established GHG reduction goals of 50% below 2010 levels by 2030 and 100% by 2050. Frederick County met both the regional 2012 and 2020 goals. Emissions from buildings and transportation saw a greater reduction than anticipated due to the 2020 pandemic.

COG completes GHG community-scale inventories for all 24 local government members, northern Virginia, and metropolitan Washington. COG GHG inventories are compliant with both the U.S. Communities Protocol for Accounting and Reporting Greenhouse Gas Emissions (USCP) and Global Protocol for Community-Scale Greenhouse Gas Inventories (GPC). The inventories measure GHG-emitting activities undertaken by residents, businesses, industry, and government located in metropolitan Washington, as well as emissions from visitors.
