# TA Set Aside Background

---

- **PURPOSE:** A federal formula program that provides funding to projects considered “alternatives” to traditional highway construction
- **FEDERAL AUTHORIZATION**
  - MAP-21 (2012) – Established as the “Transportation Alternatives Program”
  - FAST Act (2015) - Renamed “Transportation Alternatives Set- Aside”
  - IIJA (2021) – Increased funding
- **TPB ROLE:** Large MPOs are sub-allocated funds and given the responsibility for selecting projects for those funds



# Virginia: FY 2027 - 2028 Schedule



- May 30, 2025 Pre-application deadline
- September 15 Application deadline
- Sept-Dec VDOT reviewed and scored applications scores
- Dec-Jan 2026 TPB Selection Panel reviewed and scored applications
- Jan-Feb TPB staff coordinated with CTB Member D.J. Gribbin
- Feb 6 Panel recommendations announced
- Feb 18 TPB action



# Virginia Project Selection

- VDOT's Local Assistance Division oversees project solicitation & administration
- FY 2027-2028 project solicitation: April 2025 – September 2025
- Funds are split into three pots: CTB Districts, Large MPOs, & CTB statewide



# TPB Selection Process

---

- Selection Panel included staff from DDOT, MDOT, and the TPB. Staff from VDOT served as a technical resource
- Panel members individually scored projects



- The selection panel used the average scores as a basis for discussion. However, the final recommendations were based on consensus.



# Regional Policies Criteria

---

- Expanding Multimodal Transportation Options for Non-Drivers
- Supporting Regional Activity Centers
- Completing the National Capital Trail Network
- Access to High-Capacity Transit
- Increased Access in low-income areas
- Safe Routes to School
- Increased Access for People with Disabilities



# FY 2027 – 2028 Project Recommendations

---

- 16 applications were received representing a total funding request of \$27,592,756
- Total funding for TPB and CTB District Member is \$16,500,000
  - TPB suballocation: \$12,500,00
  - CTB Member DJ Gribbin's suballocation: \$4,000,000
- The TPB will consider approval of funding for 7 projects for \$12.5 million


# SRTS Crossing Improvements, Phase II

- \$2,172,769 – City of Alexandria
- Improvements include adding curb extensions with crosswalks, shortening crossing distances, and improving bus stops near George Washington MS
- A curb extension and a raised crosswalk will also be added near Charles Barrett ES, and a nearby slip lane will be removed



# Centreville Road Sidewalk

- \$2,500,000 – City of Manassas
- Design and construct 0.2 miles of sidewalk along Centreville Road between Weir Place and Prim Lane, as well as on Carriage Lane and Reb Yank Drive. Provide a pedestrian crossing across Centreville Road, a busy arterial
- Proposed improvements would help connect a residential community to the Weems Elementary School and other commercial businesses along the corridor



# Manassas Drive Shared Use Path

- \$2,388,529 – City of Manassas Park
- Construct a continuous 0.21 mi section of shared-use path on Manassas Drive from Broad Street to Railroad Drive
- Additional enhancements include new curb ramps, improvements at a rail crossing, and installation of pedestrian-scale signs and signal upgrades



# Old Carolina/Jefferson Street Sidewalk

- \$2,470,256 – Prince William County
- Constructs a segment of sidewalk along Old Carolina Road/Jefferson Street from Somerset Crossing to Fayette Street where none currently exists
- Additional enhancements include adding a crosswalk and adding a pedestrian automatic gate at the railroad crossing



# Next Steps

---

- On February 18, 2026, seek TPB approval of Resolution R10-2026 to fund recommend projects
