MAP-21, the Federal Surface Transportation Authorization bill, created a new program called Enhanced Mobility, which will provide about \$2 million a year to the region for transportation for people with disabilities and older adults. COG will become the Designated Recipient for this program, and Wendy Klancher will update the committee on the TPB's expected role.

5. **Update on the Limited Reciprocity Agreement for Wheelchair Accessible Taxicabs** ..... 1:15 p.m.

The AFA recommended that the TPB's Regional Taxicab Regulators (RTR) Task Force consider a regional reciprocity agreement limited to wheelchair-accessible taxicab trips. Members of the RTR agreed to review and discuss such a draft reciprocity agreement. At the RTR March 2013 meeting, members reviewed a draft agreement. Wendy Klancher will update the AFA on the discussions.
