Regional Roadway Safety Context

- The TPB has supported roadway safety for several decades to complement safety efforts by member jurisdictions
 - The Street Smart safety campaign was created in 2002 to educate drivers, pedestrians, and bicyclists about safe travel behaviors
 - The Transportation Safety Subcommittee was established in 2012 to provide a forum for local transportation practitioners to convene and coordinate
 - A Regional Safety Study was completed in 2020-2021; an Update is in progress
 - The Regional Roadway Safety Program was established in 2020
- Following several years of declines, the region began to experience an increase in roadway fatalities beginning in 2016.
 - The increase was especially pronounced during the pandemic
- Chair Christina Henderson made roadway safety a priority for her chairmanship





Event Overview

- The Summit took place on October 31, 2024, in Alexandria, VA
- The event aimed to:
 - Share information about current safety trends and safety frameworks
 - Facilitate the generation of potential regional safety actions the TPB could pursue
- Approximately 60 people attended in-person, including 13 Board members and alternates
- Additional members attended virtually

Safety Recommendations

In Session 3, TPB members and alternates raised ideas for action. On November 20, TPB members affirmed the following safety actions:

- Join the USDOT's <u>Allies in Action</u> partnership
- Inventory and report on safety-supportive activities undertaken by TPB members pertaining to TPB Safety Resolution R3-2021
- Conduct inventory of strategies proposed in TPB Safety Resolution (R3-2021)
- Gather more data about the impacts of automated enforcement systems
- Partner with and assist COG to develop a multijurisdictional arrangement to fully enforce traffic laws and hold dangerous drivers to account (including reciprocity of automated enforcement)
- Continue to provide input on federal safety rulemaking and coordinate with COG on regional advocacy strategies

- Regionally track/raise awareness of transportation safety funding opportunities
- Explore opportunities for enhanced driver education and training as part of driver re-certification process
- Gather information on what has worked best in Vision Zero plans elsewhere
- Initiate a regional Vision Zero plan
- Assist member jurisdictions to pursue Vision Zero activities
 - Use a systemic approach of preventive measures
 - Enhance coordination with non-transportation partners such as medical examiner offices
 - Explore emerging technologies
