# Background

---

- MWAQC and CEEPC Approve Update
  - March 2023: the Climate Energy and Environment Policy Committee (CEEPC) and the Metropolitan Washington Air Quality Committee (MWAQC) approved ACPAC to update its 2017 Environmental Justice (EJ) Toolkit
  - May 2023: Metropolitan Washington Air Quality Committee (MWAQC) adopted its FY24 work program including an objective to include a racial equity lens in work activities. The committee also included a goal of developing a new document to address EJ in air quality planning
- Other equity related work:
  - The Climate Pollution Reduction Grants (CPRG) climate plan program for the MSA requires significant new community engagement, emphasizing Justice40 and LIDAC. Outreach strategy - include EJ/Equity/Community Engagement

# EJ Toolkit Update

---

## Purpose of Toolkit Refresh

- To provide recommendations or strategies for local governments to more effectively and appropriately engage vulnerable/disfavored communities on issues related to climate, energy and air quality.
- Update recommendations, best practices, and case studies for engagement.
- Incorporate new research and EJ engagement tools.

# EJ Toolkit Update

---

- Two-pronged Approach
  - Local government workshops - COG held two sessions with local government staff that have EJ community engagement experience (February 14, and March 13).
  - Community engagement - Equival held workshops and in-person engagements with community-based organizations and grassroots communities, as well as ACPAC. They provided a Report to COG with recommendations based on the data gathered from those interviews and outreach events.
